**Fees for services:****On-Prem CMS Data access through Academic Research System (ARS)**

- Reuse data application fee paid directly to CMS:
  - One-time reuse application fee - \$2,000 and each additional amendment application fee - \$2,000\*  
***\*(Please note, in anticipation of [potential policy updates by CMS in April 2024](#), these fees are subject to change based on CMS final policy announcement.)***
  
- Access CMS data for reuse through ARS:
  - Annual access fee - \$10,500  
The fee covers a total of 75 working hours which encompass a range of services such as new project consultation, IRB guidance, DUA life cycle management, data security compliance, access to data in RAE, programmer consultation, folders provision in RAE, and technical support from ARS.
  - Additional support is available per ARS recharge rate: \$140/hour:  
Includes project-specific data analysis, analytic support, data cleaning, data wrangling, data/cohort extraction, and data harmonization.
